3. Discussion with members of the Pawnee County Economic Development Board concerning potential economic opportunities for the City of Cleveland and Pawnee County. Possible action related to same.
4. Discussion and Action to approve or reject Ordinance 2018-619: AN ORDINANCE AMENDING SECTION 12-322 OF PART 12 OF THE CLEVELAND CITY CODE REGARDING LOCATION AND AGE OF RESIDENTIAL MOBILE HOMES.
5. Discussion and Action to approve or reject Ordinance 2018-620: AN ORDINANCE AMENDING THE CITY CODE OF THE CITY OF CLEVELAND, OKLAHOMA, PART 13, TITLED "PUBLIC SAFETY", CHAPTER 1, TITLED "FIRE PREVENTION", SECTION 13-104, TITLED "LIMITS IN WHICH BULK STORAGE OF LIQUEFIED PETROLEUM GASES IS TO BE RESTRICTED." ; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE OF AUGUST 15, 2018; AND DECLARING AN EMERGENCY. This ordinance will allow for bulk storage of liquefied petroleum in certain areas of the city limits.

Discussion and action to approve or reject Ordinance 2018-621: AN ORDINANCE AMENDING THE CITY CODE OF THE CITY OF CLEVELAND, OKLAHOMA, PART 1, TITLED "GENERAL PROVISIONS", CHAPTER 1, TITLED "USE AND CONSTRUCTION OF THE CODE", AMENDING SECTION 1-111, TITLED "BOND AND FINE SCHEDULE" REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE OF JULY 31, 2018; AND DECLARING AN EMERGENCY. This Ordinance will update the City fine and bond schedule in compliance with State Law--particularly fines for illegal possession of marijuana and Speeding 1-10.
